Judicial Nominees Waiting for a Senate Confirmation Vote

Nearly half of those had bipartisan support in committee and the rest can still be confirmed because Democrats maintain a 50-49 majority in the Senate even with Senator Feinstein's absence.

Judicial Nominees Not Yet Eligible for a Committee Vote

- Twelve district and circuit court nominees are not yet eligible for a committee vote, either because they have not yet had a confirmation hearing or additional procedural steps are necessary under committee rules before they can receive a committee vote. Most of these nominees won’t be eligible for a committee vote until mid- to late- June at the earliest.
